

## **REFUND POLICY NIKECAMP**

#### 1. Right of withdrawal.

You have the right to cancel your registration in the tournament during the **14 calendar days following the date of registration**. To do so, you must notify us in writing, for which a "WITHDRAWAL FORM" is provided at the end of these stated conditions, although its use is not mandatory. Written communication will be valid as long as it is sent by the deadline. Further, it will not be necessary to indicate the reason for your withdrawal, and the money you have paid will be refunded in full within 14 calendar days from receipt of your communication.

All other cancellations will be evaluated by the organization and a resolution will be determined based on the considerations indicated below. Any case not described will be considered unique by the organization, and the organization will informe of the result.

## 2.- Cancellation of participation

In addition to exercising your right of withdrawal and depending on the time in which you communicate your desire to cancel your participation, the grounds for withdrawal shall also be taken into account. If at the moment of communicating withdrawal from participation it is proven that it is due to a medical cause, reimbursement will be made in an amount that is greater than if withdrawal is for non-medical causes. Refunds for any medical cause will require that a medical certificate be presented in which the participant is explicitly advised to not attend the camp due to their physical or health status. Thus:

- With medical certificate:
  - Cancellations until June 13: 100% of the amount paid will be refunded
  - Cancellations from June 14 until the start date of the camp: 90% of the amount paid will be refunded
  - · Cancellations once the camp begins: No amount will be refunded
- Without medical certificate:
  - Cancellations until June 13: 90% of the amount paid will be refunded
  - Cancellations from June 14 to June 29: 60% of the amount paid will be refunded
  - Cancellations from June 30 until the start date of the camp: 20% of the amount paid will be refunded
  - Cancellations once the camp begins: No amount will be refunded.

#### 3.- Refunds

All cases will be evaluated by the organization. Refunds will be made as detailed in this refund policy and, if exercising the right of withdrawal within 14 days of inscription, they will be made within 14 days following the request. In all remaining cases, they will be made following the conclusion of the Nike Camp on July 13, 2019.

#### 4.- Request methods:

Request for refunds that do not qualify as exercising the right of withdrawal must be communicated in writing, using the form provided below and sending it to <a href="mailto:andorra@nikecamp.es">andorra@nikecamp.es</a>. To determine the date on which the request was sent, the date when the email was sent will be used.
